INTRODUCTION

Genesis Hospital

Genesis HealthCare System (GENESIS) is an integrated healthcare delivery system based in Zanesville, Ohio. The system includes a not-for-profit hospital, Genesis Hospital, in Zanesville, an extensive network of more than 300 physicians and multiple outpatient care centers throughout the region. The Genesis Mission states "We serve our community by helping each person achieve optimal health and well-being by providing compassionate, exceptional, and affordable healthcare services". This Community Benefit Implementation Strategy is integral to achieving the Genesis mission.

The Genesis Vision details "Genesis is committed to being a health care team whose care exceeds the expectations of our patients and community". As the largest healthcare provider in a six-county area, referred to as the GENESIS Service Area (GSA), healthcare services are utilized by residents of Muskingum, Morgan, Perry, Coshocton, Noble and Guernsey counties. GENESIS provides a higher level of service than what is typically found in a community of its size including open-heart surgery, trauma care, a Level II special care nursery, neurosurgery, and comprehensive cancer services. This high level of care has established Genesis as a primary referral center for much of the region.

In addition to traditional hospital services, GENESIS offers a broader range of services through its affiliated organizations, which serve as GENESIS' partners to extend care far out into the community. GENESIS' steadfast commitment to delivering compassionate, exceptional, and affordable patient care has been recognized throughout the country with numerous awards and accreditations.

Community Health Needs Assessment: 2021

Genesis Hospital abides by all IRS regulations required to maintain its non-profit status. Genesis Hospital is required to conduct a Community Health Needs Assessment (CHNA) in the GSA every three years. The 2021 CHNA is the third CHNA completed by GENESIS. GENESIS, the GSA County Health Departments, and Ohio University collaborated to complete the 2021 CHNA. This partnership became the Southeastern Ohio Health Improvement Collaborative (SOHIC) and is made up of:

Coshocton City and County Health Departments, GENESIS, Morgan County Health Department, Noble County Health Department, Perry County Health Department, Zanesville-Muskingum County Health Department, Ohio Alliance for Population Health, Ohio University's (OU) College of Health Sciences and Professions, and OU's Voinovich School of Leadership and Public Service.

The full CHNA was done collaboratively to strengthen community involvement when identifying and prioritizing local health needs. Collaboration also allowed data to be gathered and used for both GENESIS and local health departments. SOHIC contracted with the Northwest Hospital Council of Ohio to design the assessment tools, add relevant secondary and mortality data, and develop the reports. The 2021 CHNA Report was adopted by the GENESIS Board of Directors in December of 2021. **This CHNA is now available to the public at www.genesishcs.org at the bottom of the front page.**

The GENESIS Community Benefit Steering Team identified six top health priorities which guide this document and are detailed in the 2021 CHNA. Additional Community Health Needs were identified by GENESIS Service Line Leaders from the CHNA, which are also included in this strategy.

TOP SIX COMMUNITY HEALTH PRIORITIES: 2022-2024

Mental Health Issues

Goal: Reduce the prevalence of substance use and the burden of mental health issues through intervention and prevention initiatives in the GSA

Brief Description of Need:

- 24% of adults reported their mental health had not been good in the past month for 8 or more days. 37% reported it was not good for 4 or more days. (2021 CHNA pg. 21)
- 17% of adults in the GSA reported feeling sad or hopeless almost every day for two weeks or more in the past year. (2021 CHNA pg. 32)
- 194 suicide deaths occurred in the GSA between 2015 2019 with numbers on the rise still. 160 of these deaths were men, 34 were women. (2021 CHNA pg. 33)
- 18% of adults reported they've experienced four or more ACES (adverse childhood experiences). (2021 CHNA pg. 48)
- 20% of the GSA self-reported as binge drinkers, and 7% reported driving after having too much to drink within the last 30 days. (2021 CHNA pg. 25)
- Genesis' Emergency Department saw 561 overdoses and 601 instances of substance use disorder in 2020. (2021 CHNA pg. 28)
- 251 unintentional overdose deaths in the GSA. (2021 CHNA pg. 27)

Strategic Focus: GENESIS Behavioral Health (GBH), Women's and Children's Services (GW&CS), SANE, Emergency Services (GEmergS) and Spiritual Care (GSC) will provide or participate in health education, health promotion, professional education, and healthcare support services, and participation in collaborations and groups focused on mental health issues.

HEART DISEASE

Goal: Reduce prevalence of heart disease through intervention and prevention initiatives in the GSA

Brief Description of Need:

- Heart disease remains the leading cause of death in the GSA (23%) and the leading cause of death in Ohio (23%). (2021 CHNA pg. 34)
- On average, 80% of the GSA has had their blood cholesterol checked within the past 5 years, this is 5% below the Ohio average (2021 CHNA pg. 36)
- 44% of the GSA has high blood cholesterol, 11% higher than both Ohio and the USA as a whole. 36% have high blood pressure. (2021 CHNA pg. 36)
- 42% of the GSA is obese (BMI of 30 or above) which is 10% higher than the USA. 32% are overweight. (2021 CHNA pg. 22)
 - O Meaning only 26% are at a healthy weight or underweight.
- 62% of the GSA engaged in physical activity or exercise for 30 minutes on 3 or more days per week. (2021 CHNA pg. 22)

CANCER

Goal: Reduce prevalence of cancer through intervention and prevention initiatives in the GSA

Brief Description of Need:

- Cancer is the second leading cause of death at 22% with Ohio at 20%. (2021 CHNA pg. 34)
- 16% of the GSA were diagnosed with cancer in their lifetime. (2021 CHNA pg. 38)
- 18/100,000 is the female mortality rate for breast cancer in the GSA with Ohio at 21. (2021 CHNA pg. 40)
- 21/100,000 is the male mortality rate for prostate cancer in the GSA with Ohio at 19. (2021 CHNA pg. 40)
- 18% of the GSA are current smokers, a major risk factor for cancer. (2021 CHNA pg. 23)
- The highest incidences of cancer in our service area, in order, are: Prostate, Lung and Bronchus, Breast, Colon and Rectum, Uterus, Other Sites/Types, Bladder, Melanoma of Skin, Non-Hodgkin's Lymphoma, Kidney & Renal Pelvis, Thyroid, and Leukemia. (2021 CHNA pg. 42)

- Strokes are the 5th leading cause of death for the GSA and Ohio at 5%. (2021 CHNA pg. 34)
- Noble and Morgan counties percentages of stroke as a leading cause of death were higher than the GSA. (2021 CHNA pg. 35)
- The GSA stroke mortality rate is 39/100,000 compared to Ohio at 43/100,000. (2021 CHNA pg.36)
- High blood pressure is a major risk factor for strokes. Adults told they had high blood pressure was 36% for the GSA and 35% for Ohio. (2021 CHNA pg. 36)

SOCIAL DETERMINANTS OF HEALTH

Goal: Address the social determinants of health through intervention and prevention initiatives in the GSA

Brief Description of Need:

All six counties in the GSA are designated by the federal government as Appalachian. In Appalachia, the distressing factors listed below influence community members' health. All counties are Federally Designated Mental Health and Dental Health Professional Shortage Areas. All counties but Muskingum are Federally Designated Primary Care Health Professional Shortage Areas.

Economic Stability

- From 2014 2018, the estimated poverty rate 17.8% of populations living in poverty in the GSA compared to 14.5% for Ohio (2021 CHNA pg. 48)
- 8% of adults reported needing help meeting their general daily needs (such as food, shelter, or paying utility bills). (2021 CHNA pg. 47)
- 6% of adults experienced more than one food insecurity issue in the past year. (2021 CHNA pg. 46)
- 9% of adults are uninsured with no health care coverage in the GSA and in Ohio (2021 CHNA pg. 11)
- 11% of adults needed to see a doctor in the past 12 months but could not because of cost. (2021 CHNA pg. 12)
- Adults reported what type of assistance they or their loved ones received in the past year:
 - 14% food, 14% health care, 14% Medicare; 11% prescription assistance; 8% acquiring disability benefits, 8% dental care, 8% electric/gas/water bills, 8% mental illness issues including depression; 7% utilities; 6% free tax preparation; 4% employment; 3% drug or alcohol addition, 3% home repair, 3% rent/mortgage, 3% transportation; 1% clothing, 1% credit counseling, 1% diapers, 1% gambling addiction, and 1% septic/well repairs (2021 CHNA pg. 47)

Covid-19

- Adults reported the COVID-19 pandemic negatively impacted them or their family's health or well-being in the following ways:
 - 20% change in mental health; 15% not seeking healthcare; 14% financial instability, 14% loss of household income; 13% change in physical health; 12% changes to employment status, 12% not seeking dental care; 11% educational challenges; 8% death or serious illness of loved one (s); 7% increased alcohol use; 6% lack of internet access; 4% lack of childcare, 4% unable to afford basic needs such as personal, household, or baby care; 3% unable to afford food; 2% housing instability; 1% increased drug use, and 1% unable to afford medicine. (2021 CHNA pg. 48)

Neighborhood & Built Environment

- 14% of adults described their neighborhood as not safe. (2021 CHNA pg. 49)
- Adults reported the following environmental issues threatened their or their family members' health in the past year:
 - 9% insects, 9% mold, 7% rodents; 5% moisture issues, 5% temperature regulation (heating and air conditioning); 3% agriculture chemicals, 3% air quality, 3% Lyme disease, 3% plumbing problems; 2% bed bugs, 2% chemicals found in household products, 2% sewage/wastewater problems, 2% unsafe water supply/wells; 1% asbestos, 1% cockroaches, 1% fracking, 1% lead paint, 1% radon, 1% safety hazards (structural problems), and 1% sanitation issues. (2021 CHNA pg. 51)
